

## Export License Instructions

Because the Optotherm IS640 infrared camera is classified under ECCN 6A003.b.4.b, the following Optotherm products are subject to control by the United States Department of Commerce:

- Sentris IS640
- Micro IS640
- EL IS640
- Thermoscreen IS640

In order for Optotherm to export these products to your country, Optotherm must apply for and receive an export license from the United States Department of Commerce's Bureau of Industry and Security.

### Export License Application Documents

Before Optotherm can apply for an export license, the following documents must be completed by the purchaser, intermediate consignee(s), and ultimate consignee/end-user and returned to Optotherm:

1. Completed Export Information Letter  
[Note: May be completed by the purchaser or ultimate consignee/end-user]
2. Export Statement of Assurance completed/signed by purchaser
3. Export Statement of Assurance completed/signed by all intermediate consignees
4. Export Statement of Assurance completed/signed by ultimate consignee/end-user

### Additional Document Required for University Use

If the product(s) will be used in a University, an additional document is required that includes the following information in letter format from the researcher:

1. Researcher name, educational background and research area concentration (if possible, include a link to the department/research webpage)
2. Research field of study and use for the product(s)
3. Description of the research program funding (describe if funding is for general scientific research or research for a specific company/product/government body)
4. Description of the security measures used to protect the thermal imaging camera from unintended use and/or theft

## Additional Document Required for the People’s Republic of China

Shipments to China require an additional document to be completed called a Statement of End-User and End-Use. This document can be obtained from the following government agency:

## **Additional Export Information**

### **STA (License Exception)**

License Exception STA authorizes (without an export license) the export, reexport and transfer (in-country) of this equipment to destinations posing a low risk of unauthorized or impermissible uses. To safeguard against reexports to destinations that are not authorized under License Exception STA, certain notification and consignee statements are required to be obtained and kept by the exporter and foreign consignee.

Shipments to the following countries can be made using the Export License Exception Symbol STA and do not require an export license:

Argentina, Australia, Austria, Belgium, Bulgaria, Canada, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Japan, Latvia, Lithuania, Luxembourg, Netherlands, New Zealand, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, South Korea, Spain, Sweden, Switzerland, Turkey, & United Kingdom.

Export documents will need to be completed and submitted to Optotherm prior to shipment stating that the purchaser and end-user understand and will comply with the conditions of using the STA license exception per US export regulations.

### **No Export Countries**

The Bureau of Industry and Security (BIS) prohibits the export of this equipment to Cuba, Iran, North Korea, Sudan, and Syria pursuant to the Export Administration Regulations (EAR).
